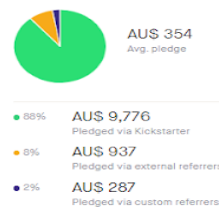

The idea for SUPER CRO started in 2010 when [Lynda Hennessy](#) and [Douglas Holmes](#) visited Kansas and witnessed how Consumer Run Organisations were contributing to supporting consumers in Kansas during the 2010 Recovery Conference. SUPER CRO is an acronym for Service Users, Participating, Education, Researching, Consumer Run Organisations.

Members of SUPER CRO have submitted an application to Kickstarter to gain some funds to kick the Recovery Box project into Stage 2. If we are successful with our goal of \$10,881 we will have 50 Recovery Boxes to distribute across Australia to further test the concept of developing a project that will allow people to access Peer Reviewed Mental Health Information. What has the SUPER CRO Responsible Persons been doing since 30 August?

The Responsible Persons for SUPER CRO held their 2nd formal meeting on 30 March 2020 and continued to work on their plan of action for the SUPER CRO over the next 12 months. This included:

1. Increase Awareness of [SUPER CRO](#)
2. Develop an action plan for Section 14 of the SUPER CRO rules
3. Promote the action plan with members and potential members of SUPER CRO
4. Plan the first Annual General Meeting for December 2019 = December 18 2020

The date has been set for the first AGM: Friday 18 December 2020. We are exploring having the AGM in the Albury/Wodonga area. The time and venue will be announced closer to the time. Pete McGee will demonstrate his Warm Fused Glass Workshop Portable Kiln and new committee members will be appointed then.

What is an Active Member of SUPER CRO?

An Active Member of SUPER CRO is a person with lived experience of mental distress or trauma background who is actively involved in the day to day activities of SUPER CRO.

We now have 23 members of SUPER CRO after the Responsible Persons confirmed this at their formal meeting on 30 March.

A letter has been sent to all members confirming their membership status.

What is Section 14 of the SUPER CRO rules?

14. Duties of the committee

1. Among its other responsibilities, the committee is responsible for making sure that:

- accurate minutes of general meetings and committee meetings are made and kept
- other records are kept in accordance with rules and
- documents of the association made available to members in accordance with rules

14.1. Committee members must:

- comply with their legal duties under Australian laws and ensure that the association complies with its duties under Australian laws, and
- meet the requirements for responsible entities (committee members) of registered charities and comply with the duties described in governance standard 5 of the regulations made under the ACNC Act which are:
 - o to exercise their powers and discharge their duties with the degree of care and diligence that a reasonable individual would exercise if they were a committee member of the association
 - o to act in good faith (fairly and honestly) in the best interests of the association and to further the charitable purpose(s) of the association set out in rule 4,
 - o not to misuse their position as a committee member
 - o not to misuse information they gain in their role as a committee member
 - o to disclose any perceived or actual material conflicts of interest o to ensure that the financial affairs of the association are managed responsibly, and
 - o not to allow the association to operate while it is insolvent.

3. For clarity, rule 16.1 is intended to require compliance with the ACNC governance standards as amended or modified from time to time.

One of the many benefits for SUPER CRO with gaining charity status with the ACNC was that we could apply to Connecting Up, provides technology donations and discounts as well as directories of nonprofits and technology suppliers, and hosts the premiere nonprofit event in the continent annually. The Recovery Box is a small box (about the size of a slice of bread) that plugs into a TV monitor through a HDMI cable.

It allows users to access a range of programs that will change how information about Recovery is made available to Consumers, Carers, Mental Health Professionals and the public.


